


Relative Spectral Emission ⁵⁾

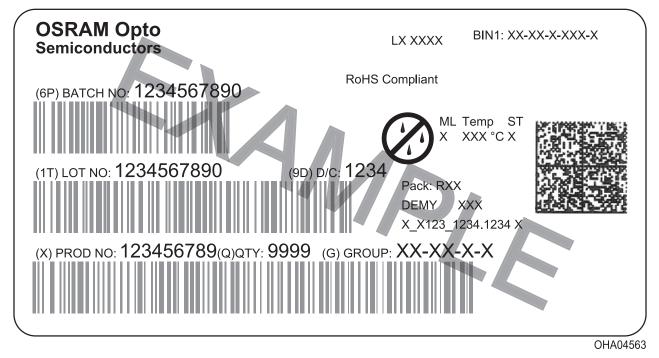
