


Relative Spectral Sensitivity ^{2), 3)}

 $S_{rel} = f(\lambda)$




Directional Characteristics ^{2), 3)}

 $S_{rel} = f(\phi)$






Photocurrent/Open-Circuit Voltage ^{2), 3)}









Dimensional Drawing ⁴⁾








