









Component Location on Pad



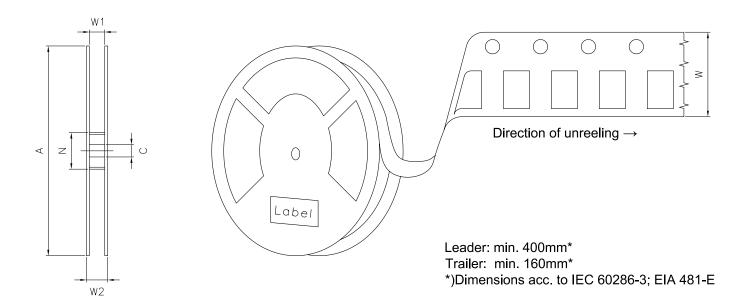



# Dry Packing Process and Materials 4)



Moisture-sensitive product is packed in a dry bag containing desiccant and a humidity card according JEDEC-STD-033.



### **Notes**
