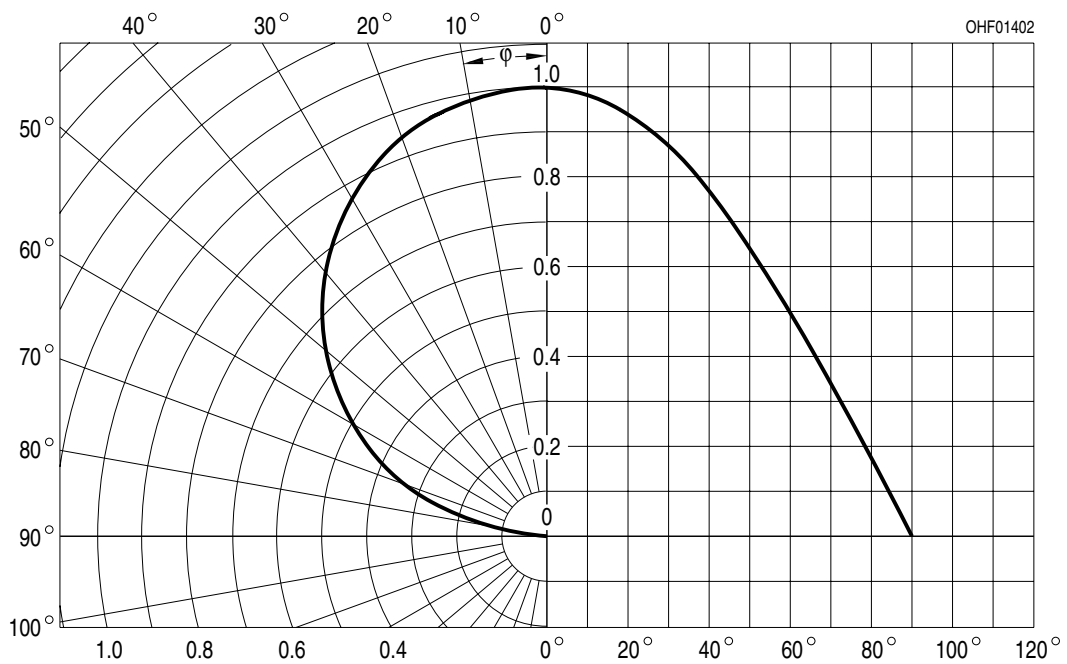

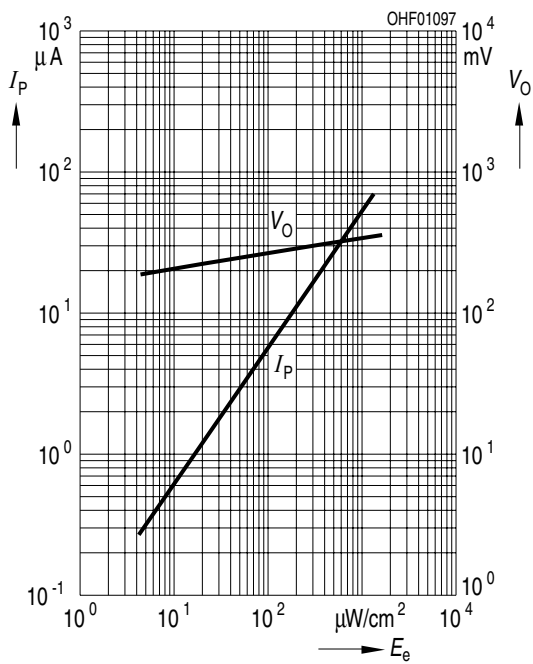

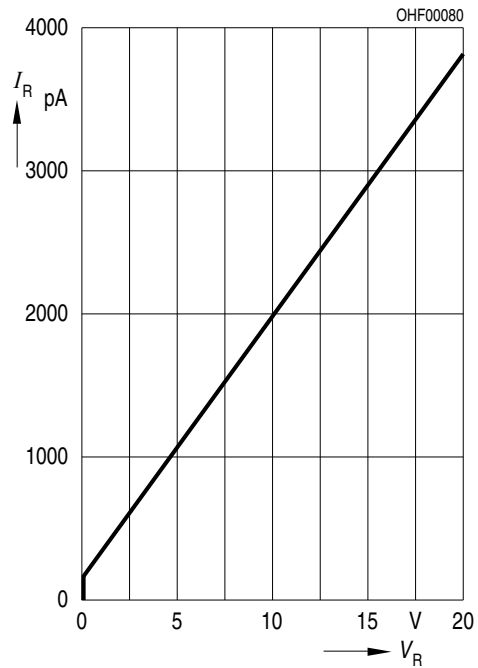

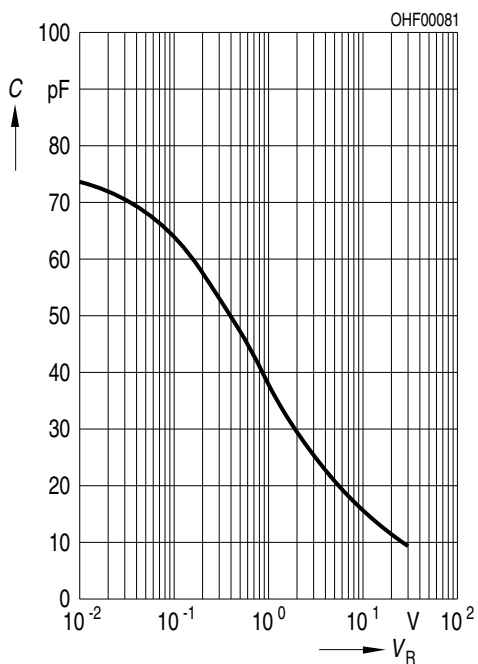

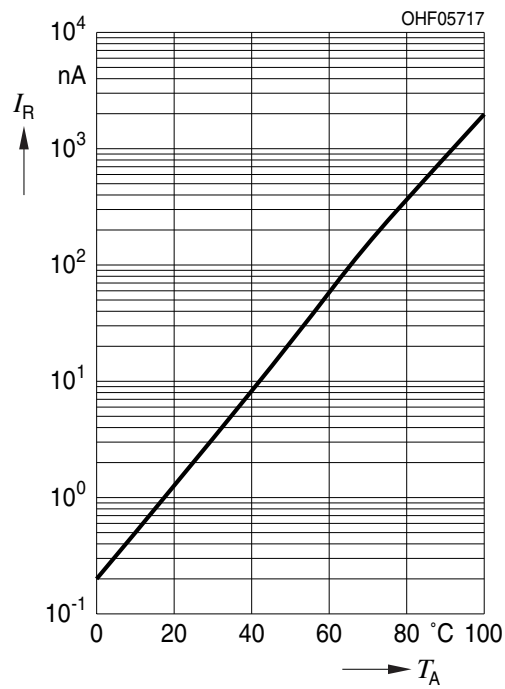

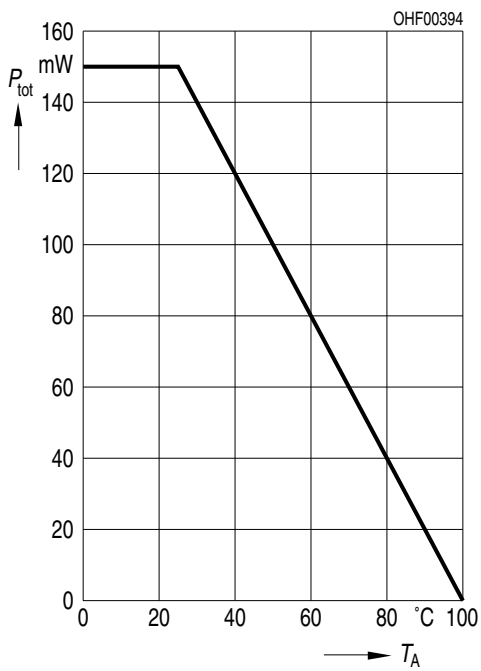
### Dark Current <sup>2)</sup>

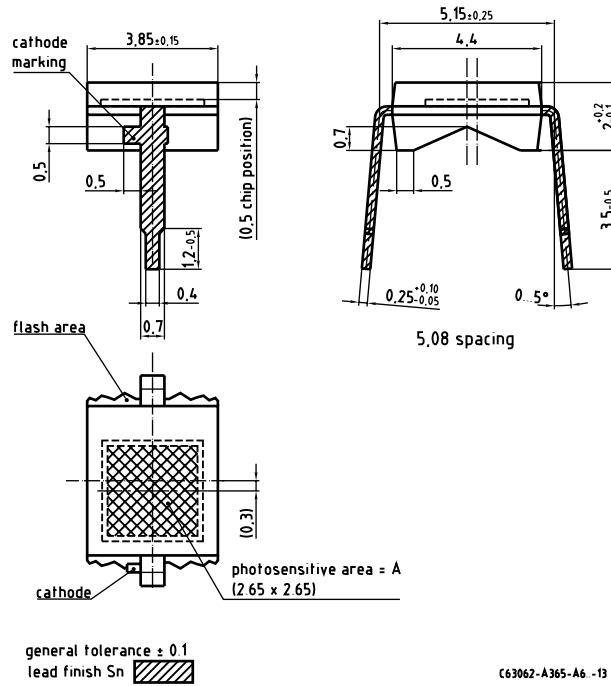
### Power Consumption

Dimensional Drawing 4)



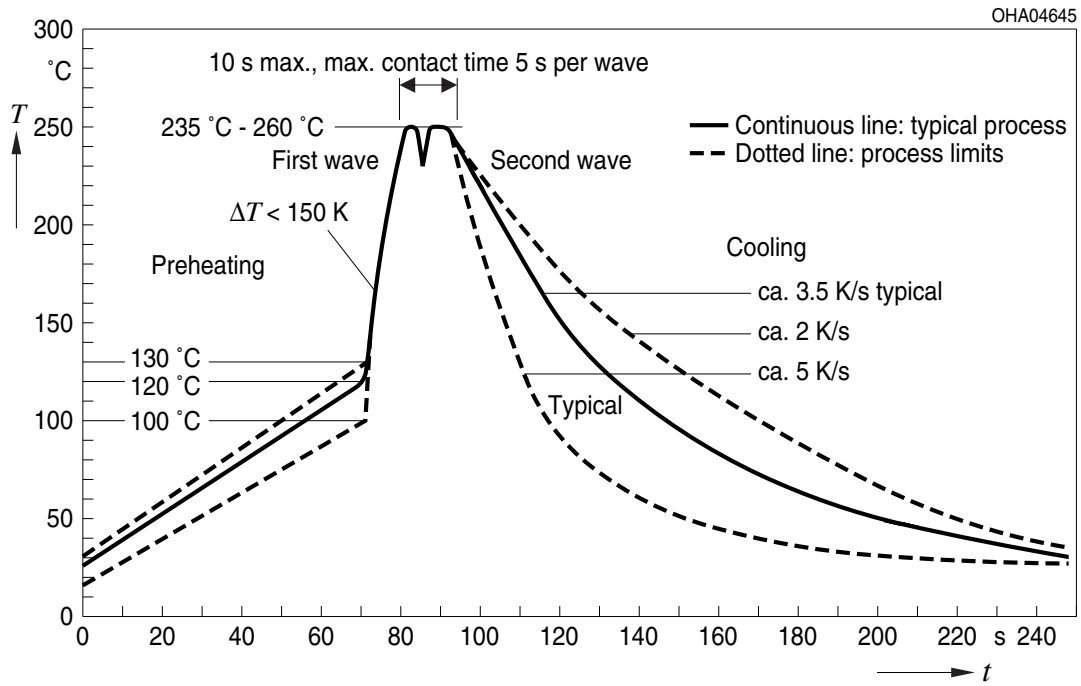

## Notes
