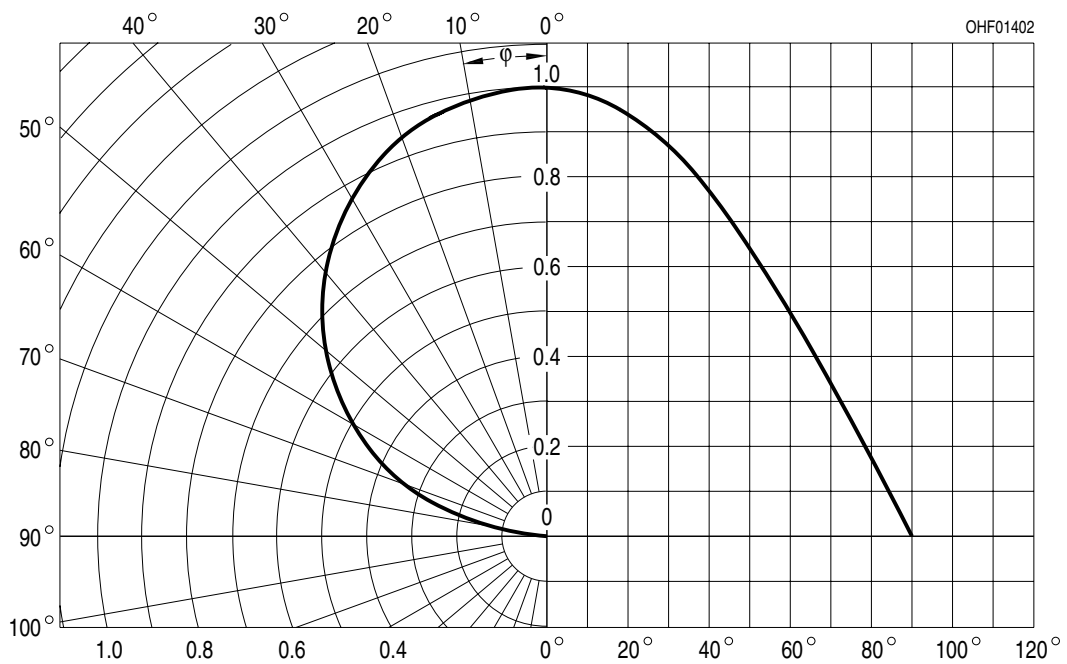

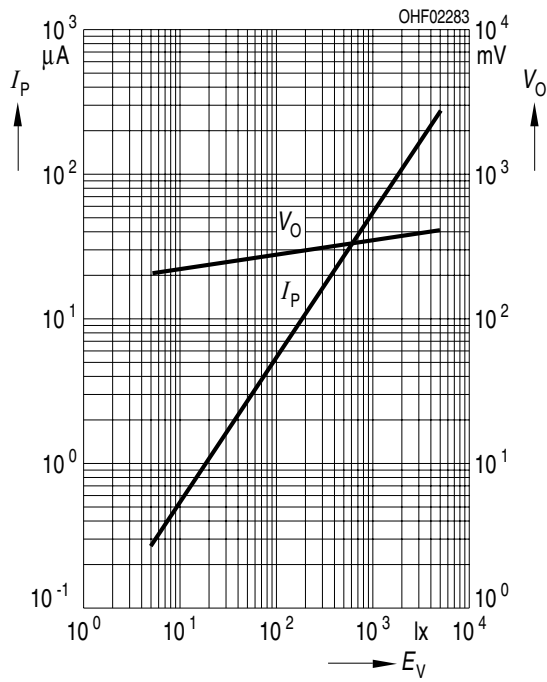
Directional Characteristics ^{2), 3)}

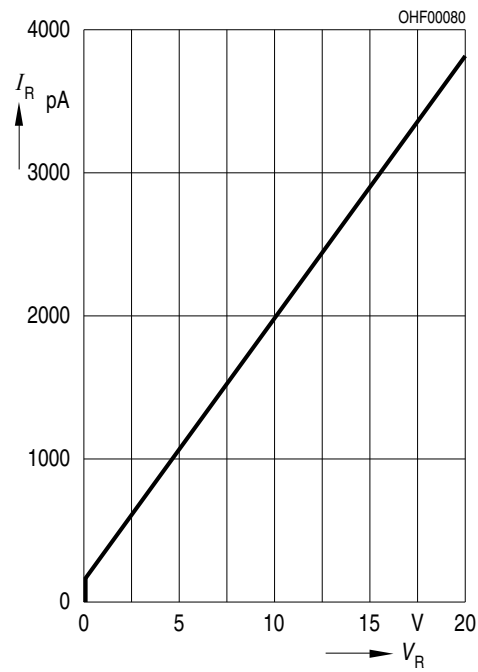
Photocurrent/Open-Circuit Voltage 2), 3)

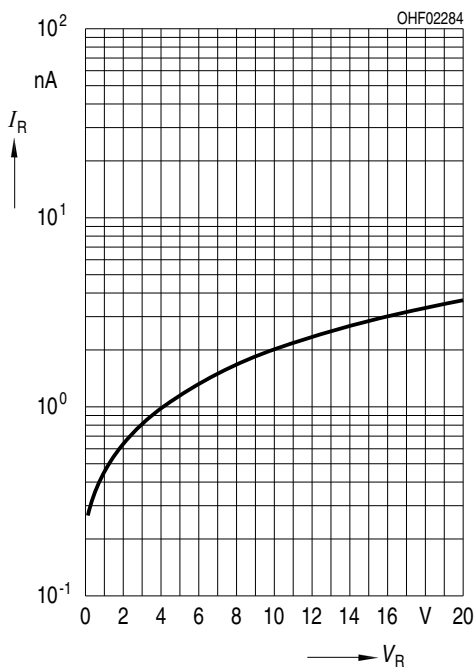

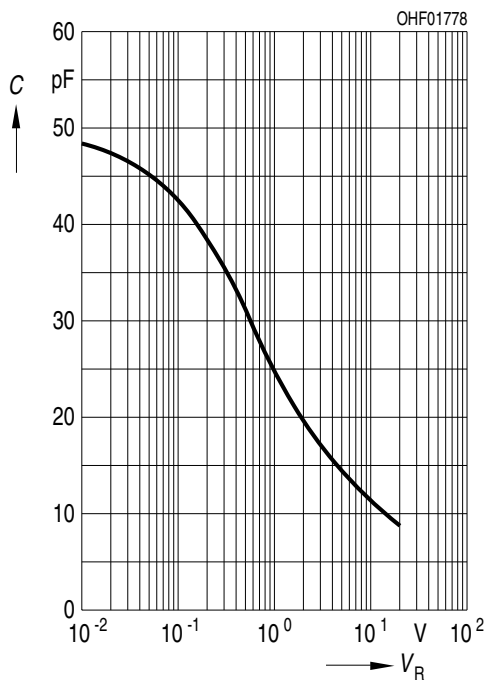

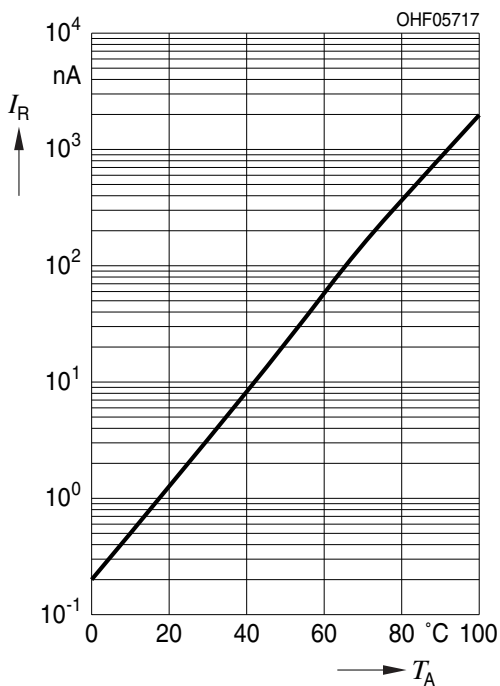

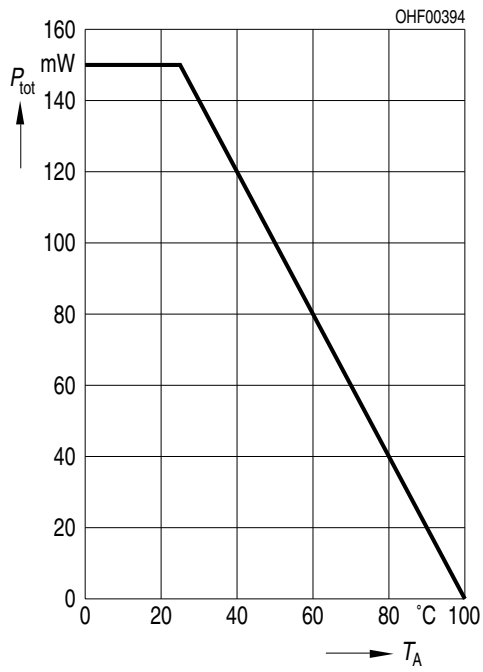
Dark Current ²⁾

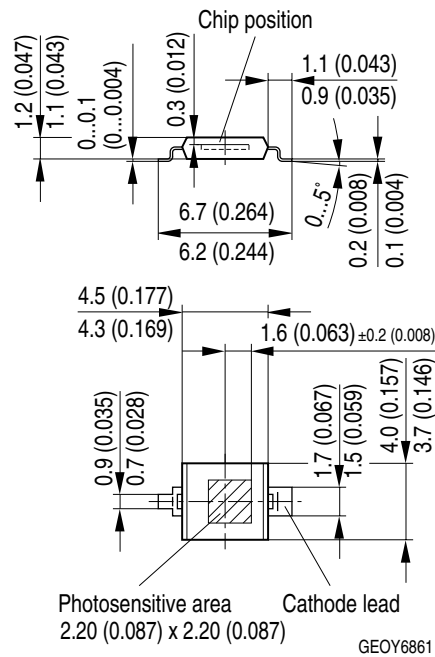


Power Consumption

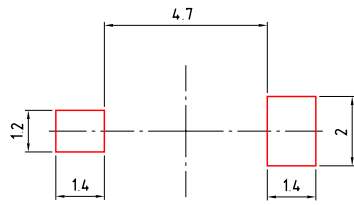

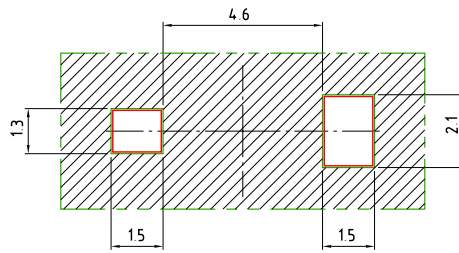

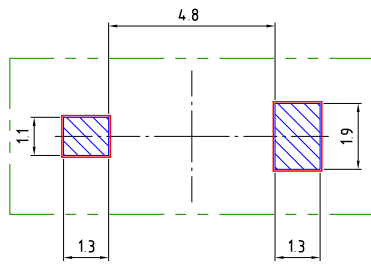
Recommended Solder Pad 4)



□ footprint

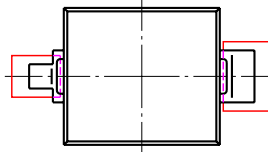

▨ solder stencil

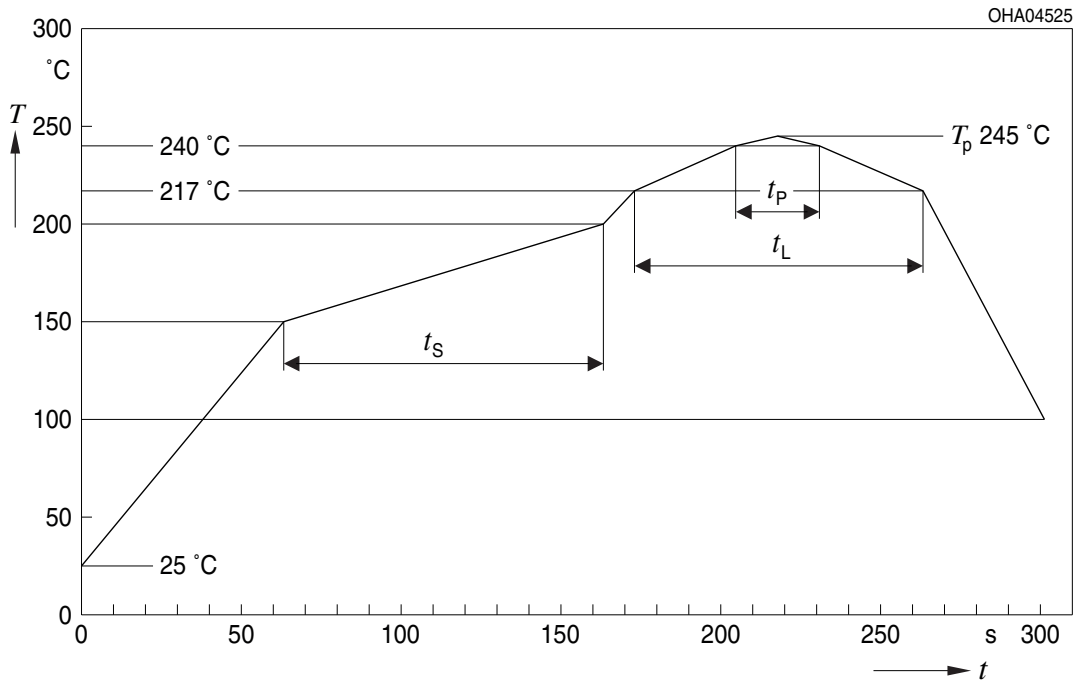
Component Location on Pad

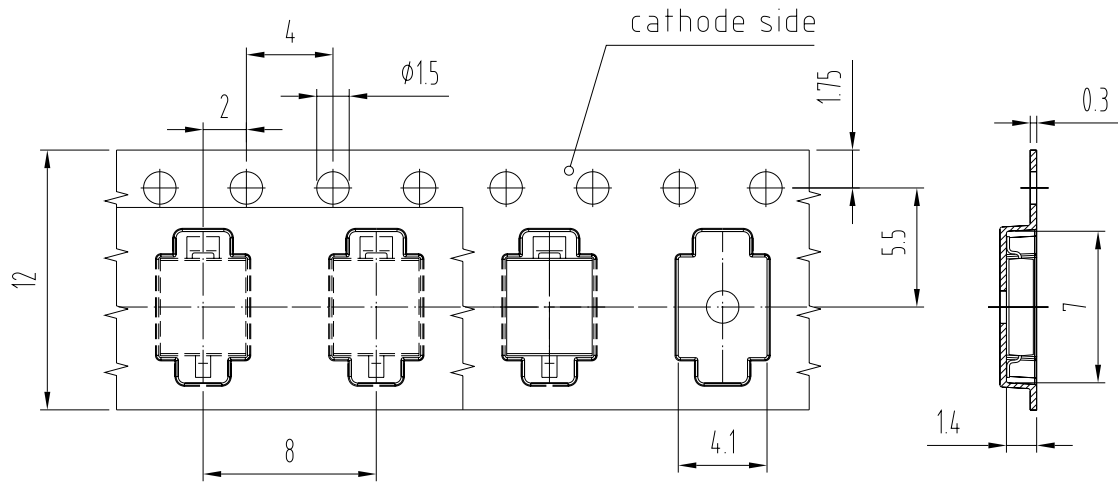

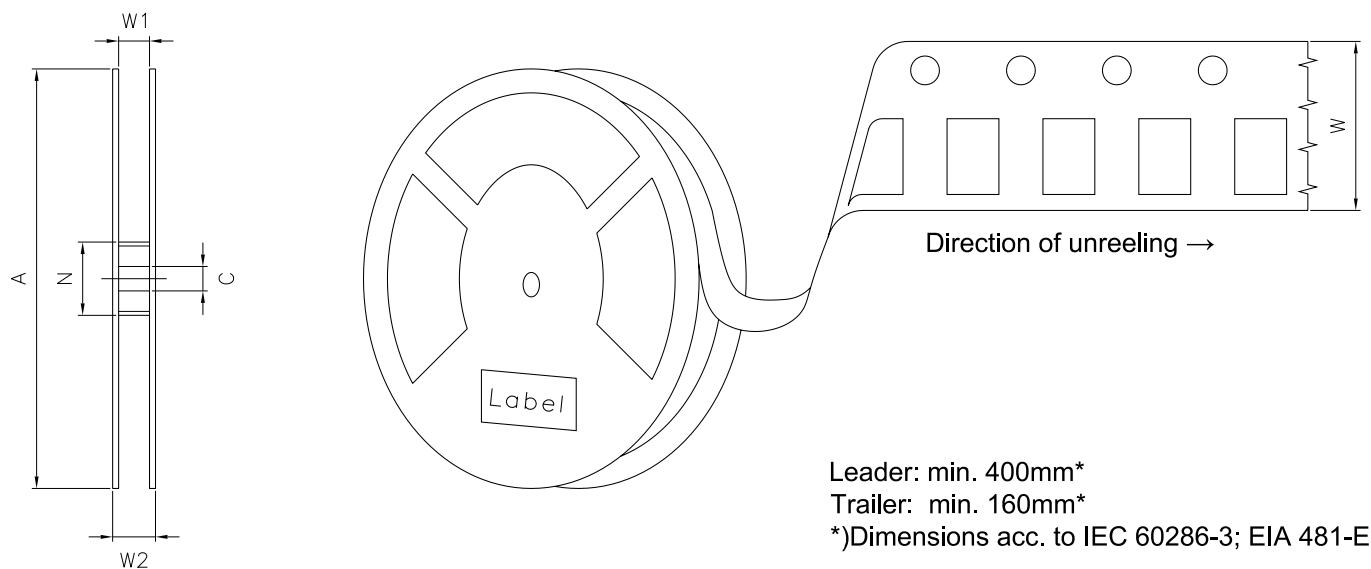

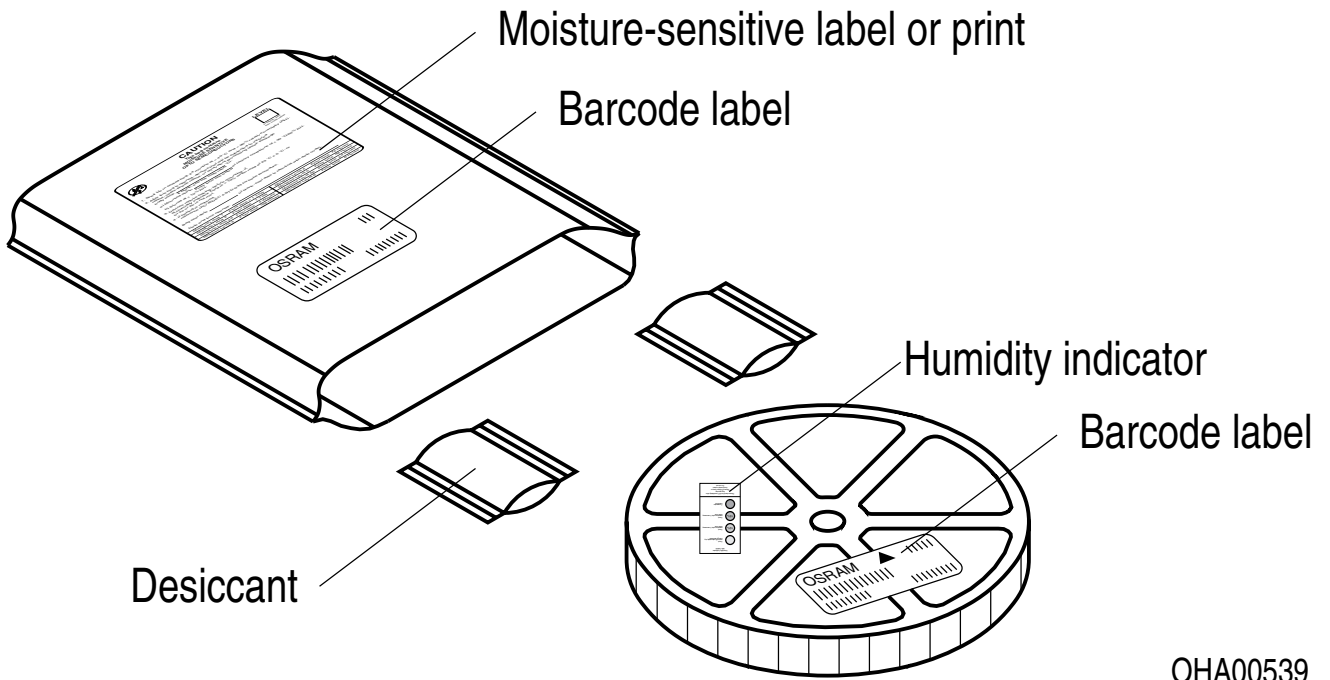

Notes
