




Relative Spectral Emission⁴⁾


Radiation Characteristics⁴⁾

I_{rel} = f (φ); T_J = 25 °C






Relative Partial Flux⁴⁾



Relative cumulated Luminous Flux⁴⁾






Relative Luminous Flux ^{4), 6)}

Chromaticity Coordinate Shift ⁴⁾






Chromaticity Coordinate Shift ⁴⁾

 ΔCx , $\Delta Cy = f(T_J)$; I_F = 24000 mA; all chips operated in parallel; within λ = 500 ... 600 nm




Relative Luminous Flux⁴⁾

 $\Phi_v/\Phi_v(25 \text{ °C}) = f(T_J); I_F = 24000 \text{ mA};$ all chips operated in parallel




Chromaticity Coordinate Shift 4)




Electrical Internal Circuit



Schematic Transportation Box 7)


